HPLC analysis can yield inconsistent results for Δ8-THC and Δ9-THC due to isomer interference. GC MS/MS was employed to avoid this issue. Please note, if THCa is present, the Δ9-THC level measured by GC MS/MS might be higher due to decarboxylation.
